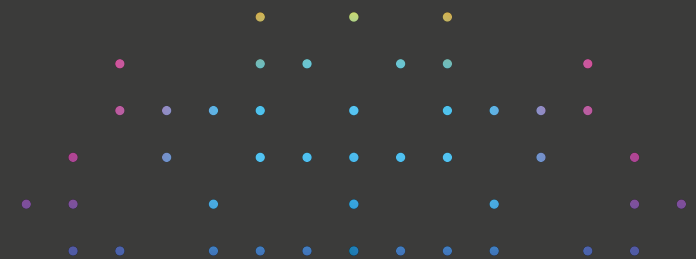

About ACCA DipIFR.



The Diploma in International Financial Reporting is an internationally recognised qualification in financial accounting covering **International Financial Reporting Standards (IFRS / IAS)**.

It is **developed by the ACCA** (Association of Chartered Certified Accountants) and is addressed to finance professionals who already have experience in accounting, using local standards. In order to obtain the DipIFR diploma, you need to pass one exam by scoring 50 out of a possible 100 points. The exams are organised in two sessions per year: in June and in December.






Admission criteria

To register as an ACCA DipIFR student, you must meet one of the following conditions:

-  2 years of relevant accounting experience and a relevant degree (allowing at least ACCA qualification exemptions for the Applied Knowledge and Corporate and Business Law (LW) exams) OR
-  2 years of relevant accounting experience and ACCA Certificate in International Financial Reporting OR
-  3 years of relevant accounting experience OR
-  ACCA Affiliate status (passed all ACCA qualification exams) OR
-  Membership of an IFAC (International Federation of Accountants) member organisation, e.g. Association of Accountants in Poland, Polish Chamber of Statutory Auditors.




Dates & fees

Registration with ACCA and exam enrolment must take place within the relevant deadlines:

-  Registration with ACCA is required to sit the exam - for the December 2025 sitting, the registration deadline is 6 October 2025.
-  Once registered, the candidate has until until 27 October 2025 to register for the exam via myACCA account.
-  Initial registration fee - £89
-  Examination fee - £155
-  As part of the ACCA Administration Service, we can manage the registration process, exam registration and payment of the above fees on your behalf. BPP administration is a six-monthly service which costs 50 PLN net per term. More information about this service can be found [here](#).

Registration documents

The following documents are required to submit a DipIFR application:

-  Proof of identity - one of the following documents: driving licence, identity card, passport or birth certificate.
-  Copy of diploma from studies and diploma supplement in English (if the documents have not been issued by the university in English, then in the language of issue and their sworn translation into English).
-  Work experience form (if you are registering using the work experience requirement).
